

PRENOTATION OF TABLES

To book one or more tables to " REPTILMANIA " is necessary to compile the module d'inscription in each part and confirm the regulation.

The tables should be payed before and the prenotation does not provide **the right of withdrawal**.

The payment should be done within e not more than **30gg of the prenotation** by bank transfer.
The bank account will be comunicated by e-mail when the module d'inscription is all compiled.

The tables is **200cm** on length x **70cm on width**.

The price of 1 table is **30€ + vat 22%** .

There are the "special offers" for whom to book many tables, in these cases it must compile the request and then a responsible will contact you as soon as possible.

Each exhibitor has the right of **2 pass** of input for the exhibition day, **each pass plus has the price of €6.00**.

The disposal of the tables could have changes.

The inscription is valid only then the confirmation by the organization when it receive the payment by bank transfer.

MANAGEMENT OF THE EXHIBITION SPACE RESPONSIBILITY

In “ **REPTILMANIA** ” it is not possible to do shows with peoples and/ or animals.

Advise to bring extension cords, power strips and adapters 220V industrial socket with plaster.

The Offenders will be immediately and irrevocably removed from
"REPTILMANIA".

ATTENTION

LIMITATIONS AND BEHAVIORAL NORMS

In “ **REPTILMANIA** ” there is the possibility to give and change small mammals, reptiles, amphibia, rodents, plants, equipment, books, and accessories.

There is not the possibility to introduce volatile in the halls.

Any species within the CITES protection list (Convention Washington app I and II) or in the list on the Berne Conventions should be categorically associated documentation.

Animals exposed must be submitted in suitable containers to the size and needs of individual species, which implies the availability of a source of drinking water for species that require it.

It must use substrate within each box (sawdust, sand, paper, peat, Aspen, etc...).

We do not provide measures for stationary containers, trusting in the good sense of how each of detention of animals, provided that the animals must be able to move easily, and that for any case of manifest inadequacy of tubs and boxes, the organizers reserve the right to intervene by making the measures it deems appropriate.

All species should be exhibit excellent health.

Animals judged suspicious precarious state of health will be removed.

It' strictly NO SMOKING inside the halls.

PRESENTATION OF THE SPECIES

For each animal is requested a label with the name of the farmer or farm the scientific name, sex, origin (country of origin) and the letter indicating the production method (CB,CH, WC, etc...).

The sigles will be accepted:

- **CB :** Born in captivity
- **WC :** Caught in the wild
- **Farm-Raised :** Born in a farm in the country of origin

It is good but not required the specification of the common name (if it exists), age (if deductible) an that the species can reach sizes.

For animals that can release toxins in any way (for example opistoglifi snakes, salamanders, toads) is mandatory indication of toxicity.

PROHIBITIONS AND LIMITATIONS

It is absolutely prohibited, display, sell or just bring in REPTILMANIA any species included in the LIST OF DANGEROUS ANIMALS performed by the Ministerial Decree:
19/04/1996,15/05/2001,03/07/2003.

The transgressors will be removed from the event with immediate effect.

IMPORTANT

It 's handling of the animals permitted only under the close supervision of breeders, however, and as little as possible.

It is not allowed access to dogs, cats and other animals are not expressly authorized.

Failure to comply with the regulation will be punished according to law and with the expulsion from the event.

Performances of exhibitionism with persons handling animals for no reason, or worse, moving with snakes around their necks and the like **WILL NOT BE TOLERATED**, respect for the decency of the industry and the safety of visitors.

All violators will be immediately and irrevocably removed from "REPTILMANIA".
